Key Duties

Site Operative, Aggregate Manufacture:



- To assist with manufacturing process, operating the plant control system and carry out minor maintenance.
- Operate the Loading Shovel and Forklift Truck when required.
- To work in an efficient and productive manner, without the need for continual direct supervision.
- To inform the Shift Supervisor promptly when issues arise affecting production or equipment.
- To assist the Shift Supervisor to ensure that all required daily, weekly, and monthly tasks are completed and recorded properly, and to ensure that any shift issues are reported at the earliest opportunity.
- Maintain a high level of awareness within the Plant for Health, Safety, Welfare and Security matters and in this respect to lead by example and take a pro-active approach.
- To ensure the plant and site are maintained in a clean and tidy condition, including cleaning of mixers and confined spaces using tools such as pneumatic hammers.
- Willingness to undertake training and learn new skills, required for efficient operations, such as operating mobile plant, plant maintenance, first aid, confined space working etc.
- Be able to perform cleaning duties in confined spaces and at heights.
- Carry out any other duty required by the Site Manager or Senior Shift Supervisor.
